It is understood by the Renter that the present minimum monthly charge is \$15.00, which includes 1,000 gallons of water at the rate of \$9.45 per 1,000 gallons, and that this application is NOT transferrable and pertains only to the specific property and applicant described above. Water rates are subject to change.

The Renter agrees to pay at the time of signing this application the sum of \$250 (\$200 refundable deposit (leave the district) and a \$50 connection fee). The final water bill shall be deducted from the deposit. The remainder of the deposit shall be returned to the Renter by Corinth Water District at the address supplied by the Renter. Failure of Renter to supply a current address to Corinth Water District for the purpose of returning any deposit remaining relieves the district of the obligation to ascertain a forwarding address and will cause a forfeiting of the deposit to the Water District 60 days after the date of the last water bill.

Fees & Penalties:

- a. 10% minimum penalty will be added to balances if not paid by due date.
- b. \$17.00 service charge on all returned checks.
- c. Disconnection fee for non-payment is \$100.00.
- d. After service has been disconnected for non-payment, the deposit on the account will be updated to the current requirement and an additional deposit will be due equal to three (3) average monthly bills.

Renter agrees to pay all attorney fees and costs incurred by Corinth Water District in the event it is necessary for Corinth Water District to retain counsel to pursue collection of sums due to Corinth Water District by Renter, to enforce any of the rules, regulation or ordinances of Corinth Water District or any other reason related to this water service application.

The processing fee for online payments up to \$50.00 will be \$1.75. Over \$50.00 will be 3.5% of the total payment. (Processing fees are subject to change) **No cash will be accepted for payments.**

Failure to receive a bill or disconnect letter does not relieve customer of liability to pay bill, the applied late fee, and be disconnected for Nonpayment.
